

4-: The Trustees shall be:

(1) Kaptan singh S/o Shri Bhagwan singh R/o Gwalior

(2) Abhay Kumar Gupta S/o Shri chathurbuj Gupta R/o 33/3C-1 Loiya Nagar Balkeshwar Agra

(3) Mamta Gupta W/o Shri Abhay Kumar Gupta R/o 33/3C-1 Loiya Nagar Balkeshwar Agra

(4) Smt. Sushila Singh W/o Shri Kaptan Singh R/o Gwalior

5-: The above named All Trustees shall be Trustees for life. The Trustees can co-opt with mutual consent any other person or persons, as trustees. The total number of Trustees at any time shall however not eleven exceed. That all the Trustees would constitute Board of Trustees and Shri Abhay Kumar Gupta would be the Managing Trustee. On the death of "Life Trustee" the remaining Life Trustees shall appoint a person/persons as Trustee(s) in place of the deceased from among the legal heirs of the deceased, the new legal heirs would also be life Trustees. The minimum number of Trustees shall be three.

(6) Administration: Shri Abhay Kumar Gupta & Shri Kaptan Singh is hereby authorized to make the administration of the affairs of the Trust

with the approval of the Board of the Trustees. Any question arising in the administration of the Trust shall be decided by a vote of the majority of the Trustees as are present and voting at a duly convened meeting. The Trustees will be Honorary and are not entitled to any remuneration. However, they would be entitled for travelling and such other expenses incurred for the Trust to achieve its objects, as the Board may deem fit and reasonable.

- (7) Powers of the Trustees:- The Trustees shall have and may exercise all such powers, as it. Their opinion shall enable them to effectively carry out all or any of the Trust Purposes. Without prejudice to the generality of the foregoing, the Trustees shall have the power:
 - (a) To purchase, hire, take on lease or invest the corpus of the Trust Fund or any part thereof, in lands and in movable and immovable properties;
 - (b) To accept gift/donations in kind or in cash;
 - (c) To gift/donate the funds to the institutions/ society/ Trusts established for public charitable purpose and approved U/s 80G of I.T.Act, 1961.

(d) To borrow funds/ financial aid on such terms and conditions from private/govt. institutions/semi govt. institutions/ public banking sector subject to payment of interest or otherwise as the Trustees may onsides necessary or desirable to achieve the object of the

(e) To sell, mortgage charge, lease, hire, Invest or transpose the Trust

Investments/ properties;

(f) To open Bank accounts and generally deal with the Trust Fund or any part thereof as the Trustees may onsides necessary or desirable;

(g) To raise additional funds for augmenting the corpus of the Trust Fund, if necessary through appropriate programmers, to support

the Trust objects:

(h) To accumulate the income of the trust of eventual application to the Trust Objects pending which to invest the accumulation in accordance with the relevant provisions of the Income Tax Act.1961;

(i) To employ persons to assist the Trustees in carrying out the Trust

Purposes.

(8) Operation of Bank account. The Managing Trustee is hereby authorized to open and operate any type of bank account with any of the scheduled Bank jointly with trustee No. 1 or 4 till further change in constitution of the Trust.

(9) The funds and properties of the trust shall consist of:

(a) The sum of Rs 5,100/-(Rs fifty one hundred) which has been settled

by the settler.

(b) Gifts/donations either in cash or in kind which may be made by any philanthropic institutions/persons or members of the public who are in sympathy with the aims and objects set out herein including any donations made for any such specified purpose or objects.



(c) Properties movable and immovable which may be acquired by the Trust by purchase, exchange lease, gift or otherwise.

(d) Income and profits from the properties of the Trust.

(e) Any fees, charges, etc, as may be collected, in the course of any public or private performance by artists, etc.

(10) The Managing Trustee is hereby authorized to make all legal formalities to get the Trust Registered U/s 12A /U/s 80G of I.T.Act, 1961.

(11) The objects of the trust shall be any or all of the following:

(a) Advancement and propagation of education and learning including establishment, maintenance and support of schools, colleges and other educational institutions.

(b) To make provisions to advance the cause of, and impart Nursery, Primary, Secondary, Higher, Commercial, Industrial, Technical,

Physical and all or any other type or kind of education.

(c) To establish, maintain, take over management, administer or run any institutions/ schools affiliated to C.B.S.E/I.C.S.E/U.P.Board and colleges/degree colleges affiliated to any university or Technical University engaged in the imparting of education to students up to any level and stream that may be found necessary and/or desirable.

(d) To generally impart education to children and for the purpose to

do all acts that may be necessary.

(e) To establish, run, manage, and administer any institution or college or school to train persons to be teachers who will impart education to children and/or students in School. Colleges and other similar institutions i.e BTC B.Ed, B.P.Ed, Law colleges etc.

(f) To promote adult and Kids education and welfare.

(g) To establish yoga, mediation, sports and other similar health centers.

- (14) The Trustees shall at their discretion, acquire, purchase or sell immovable properties or movable properties in the course of managing of trust. However, any sale of any sale of immovable shall require prior consent of at least three fourth majorities of the trustees.
- (15) No income of the trust shall be applied for the personal benefits either of the Trustees or of the settler.
- (16) The event of dissolution or winding upon the Trust, the assets remaining as on the date of dissolution shall under no circumstances be distributed among the Trustees/Members of the Managing committee/ Members of the Governing Body, the same shall be transferred to another charitable Trust, Society, Association or Institution whose objects are similar to those of this trust and which enjoys recognition under relevant section of the Income Tax Act 1961.
- (17) No amendment violating the Income Tax provisions to the terms of this deed shall be made without obtaining the prior written permission of the commissioner of Income Tax. However the amendments not violating the provision of the Income Tax Act 1961 may be made with the approval of the board of the Trustees in interest of achieving the object of the Trust.
- (18) The Trust formed is irrevocable.
- (19) The funds/Income of the Trust shall be solely utilized for achieving the objects of the Trust and no portion of it shall be utilized for the benefit of the Trustees by way of Interest, bonus, dividend, profit etc.
- (20) The benefits of the trust shall be open to all Indians irrespective of caste creed or religion.
